

State Health Access Profile: A Chartbook of Health Care Access Indicators for States

STATE HEALTH ACCESS PROFILE

The University of Minnesota's State Health Access Data Assistance Center (SHADAC) is funded by The Robert Wood Johnson Foundation to help states monitor rates of health insurance coverage. In this capacity, SHADAC provides targeted policy analysis and technical assistance to states that are conducting their own health insurance surveys and/or using data from national surveys.

SHADAC's broader mission is to understand the various factors associated with access to health care in the states. Health insurance coverage, albeit an important component, is just one of these factors. But for some populations, coverage is not a viable vehicle for obtaining services. A focus on health insurance coverage alone misses key differences across states in public program characteristics, the availability of safety net services, employer markets, and system-wide health care resources.

The State Health Access Profile is a state-level profile of access to health care in the states that goes beyond indicators of health insurance coverage. SHADAC researchers identified and assembled indicators that measure state resources that enable access to health care for residents. While many sources of data on health care access exist, the State Health Access Profile includes 14 measures that: (1) have underpinnings in the theoretical or empirical literature; (2) are readily available in the 50 states and the District of Columbia; and (3) are likely to be provided consistently in the future.

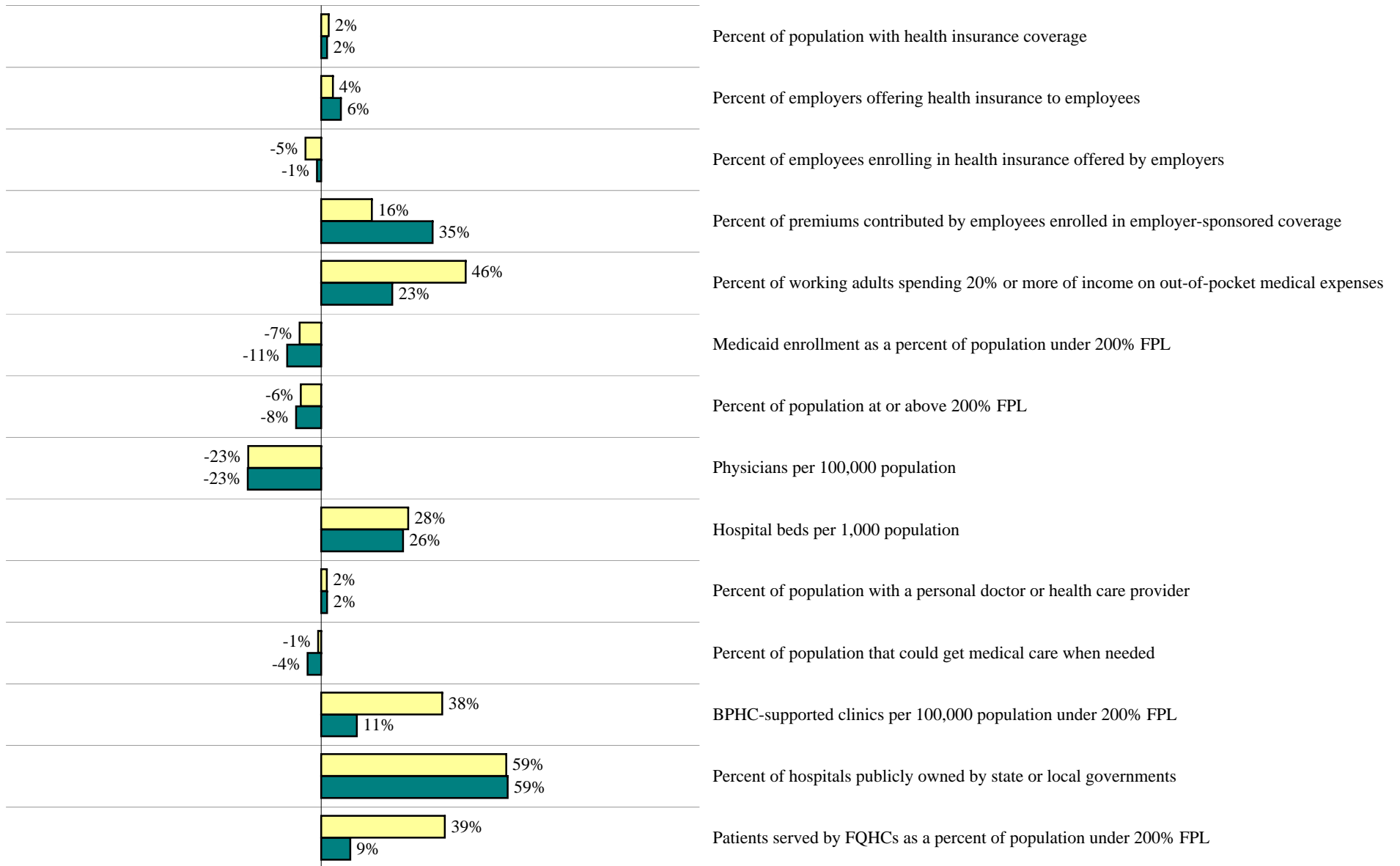

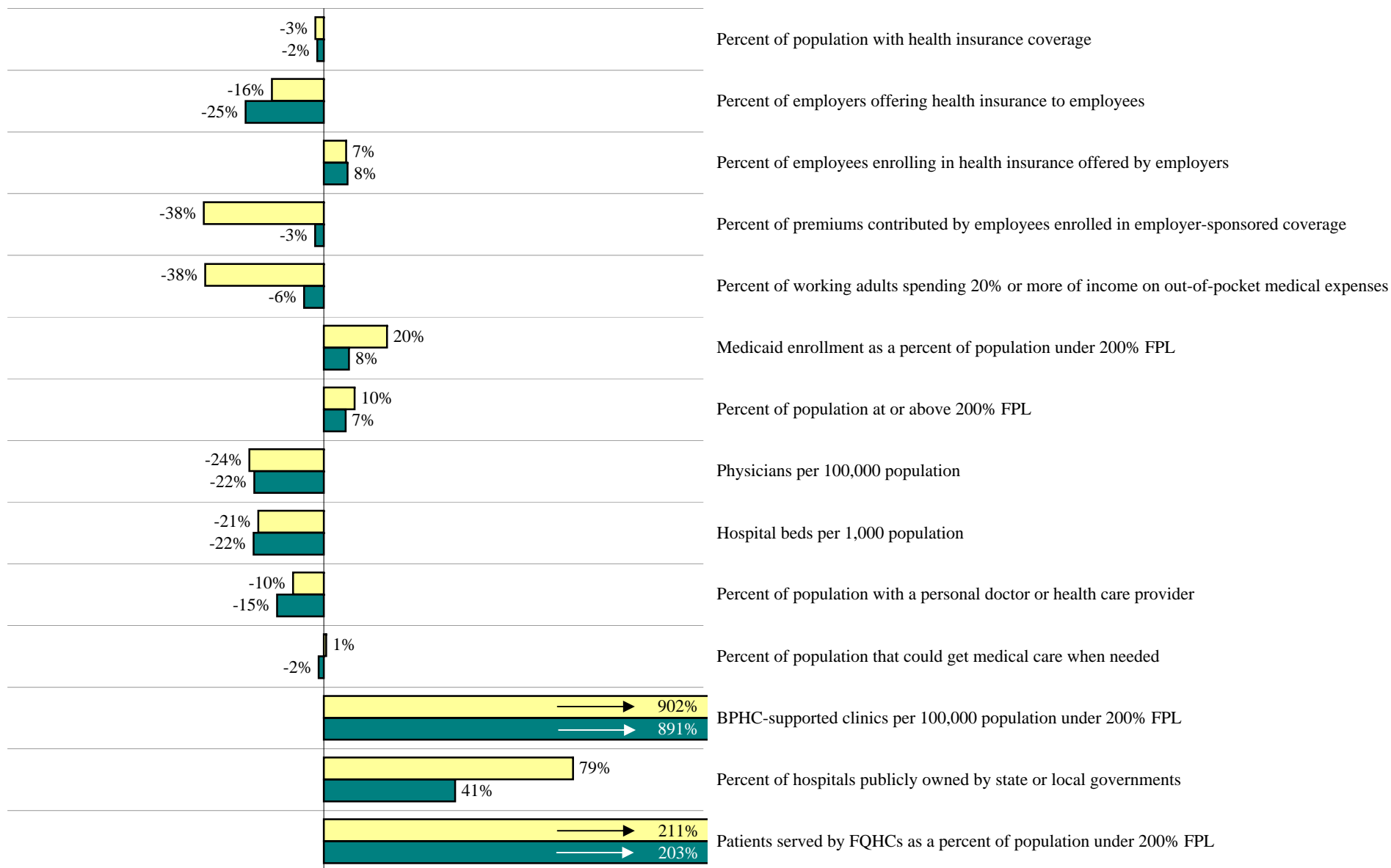

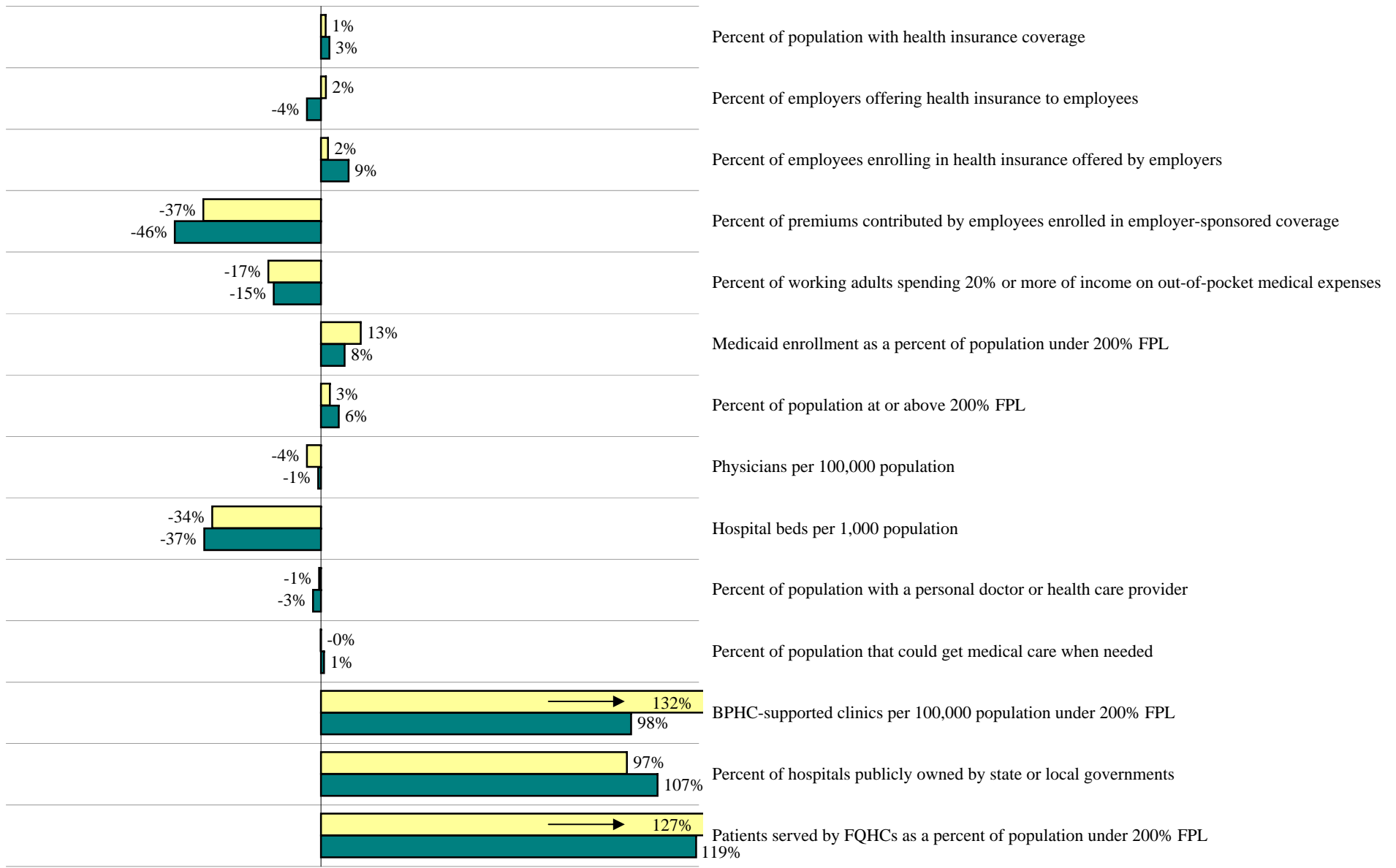
